COAR Affiliates can apply for two types of local membership, individual and corporate. Please see the below description of each type of membership.

### Individual Affiliate Membership

COAR encourages our affiliate members to get actively involved in the association and to network and receive exposure with our members through various opportunities throughout the year. For an office with one (1) or two (2) people wishing to be an affiliate, you would be eligible to apply for an individual affiliate membership. The fee for an individual affiliate membership is \$100.00 per year.

### Corporate Affiliate Membership

COAR encourages our affiliate members to get actively involved in the association and to network and receive exposure with our members through various opportunities throughout the year. For offices with three (3) or more people looking to get involved with COAR as an affiliate, they would be eligible for a combined corporate membership of \$200.00 annually. There is no limit to the number of affiliates within an office who can be included in a corporate affiliate membership. If applying for affiliate membership, COAR requires that you complete the Corporate Affiliate Membership Sheet listing all the individuals who you wish to include in your corporate affiliate membership.

Please note that if you are an office with more than three (3) people but only wish to have one (1) or two (2) individuals apply for affiliate membership, they can do so by applying for Individual Affiliate Membership only.
